### SECTION 4: First aid measures

#### Description of first aid measures

<b>General information</b>	Get medical attention if any discomfort continues. Show this Safety Data Sheet to the medical personnel.

### Advice for firefighters

**Protective actions during firefighting** Avoid breathing fire gases or vapours. Evacuate area. #### Appropriate engineering controls
