Travabon® Special PURE is a special, non-oily, skin protectant containing pigments which features outstanding protective action against water-insoluble workplace substances.

AREA OF APPLICATION

When working with water-insoluble workplace substances as well as mineral oils and greases, metalworking oils not mixed with water (e.g. cutting oils). Facilitates skin cleansing when working with multiplecomponent resins (epoxy and polyester resins etc.). Travabon® Special PURE can also be used on the face.

INSTRUCTIONS FOR USE

- Wash and dry the skin thoroughly before each application
- Then carefully rub Travabon® Special PURE on to the areas of skin at risk, including between the fingers and on the fingernails
