Migration analysis plastics Samples of the product, or a similar product made from identical plastic material, have

Test conditions for overall migration were OM0 (30 min at 40 °C)

Food simulants used for overall migration were 50 % ethanol (simulant D1) and 3 %  $\,$ 

acetic acid (simulant B).
