### Description:

Hood: Made from Proban-treated cotton canvas for head coverage protection.

Construction: Composed of three pieces sewn together, which are attached to a piece approximately 150 mm wide to form a neck protection flap. It includes an internal cord adjustment for the face.

Sewing: Made with flame-resistant para-aramid thread.

Variants: This garment can be made in different colors: green, red, blue, orange, and gray.

### Recommendations:

Usage: Suitable for welding, grinding, and sanding, according to the indicated class.

Protection: Offers limited flame propagation protection, protection against small splashes of molten metal, radiant heat, and short-duration accidental electrical contact.

Shelf Life: 5 years from the date of manufacture.

### Protection Limits:

Type: Protection clothing used during welding and related techniques, Class 1.

Restrictions: Not for use with chemical or liquid handling.

Usage: Must be worn properly tightened and closed, and always in combination with a protective jacket with similar protection performance to ensure complete coverage of the adjustment area.

Complete Protection: For adequate full protection against welding risks, additional PPE covered by other standards should be worn to protect the body, hands, and feet.

### Conditioning, Maintenance & Storage:

Conditioning: The garment is packaged individually.

Maintenance: No special maintenance is required.

Storage: Store the garment in a place protected from light, cool, dry, and ventilated.

Pre-Use Check: Before use, visually inspect the garment to ensure it is free of defects, holes, tears, or excessive wear. If the user experiences symptoms similar to sunburn, UVB rays may have penetrated. In such cases, repair or replace the garment and consider using additional, more resistant protective layers.

### Recycling:

Disposal: Safe destruction by mechanical destruction or incineration.

### Marking:

CE Marking: The CE marking on this hood indicates compliance with the essential health and safety requirements of the European Regulation 2016/425 concerning personal protective equipment (PPE).

### Safety:

Substances: We declare that the product does not contain substances at levels known or suspected to have harmful effects on the hygiene or health of the user under foreseeable conditions of use. Its design does not cause any irritation or discomfort to the wearer.
