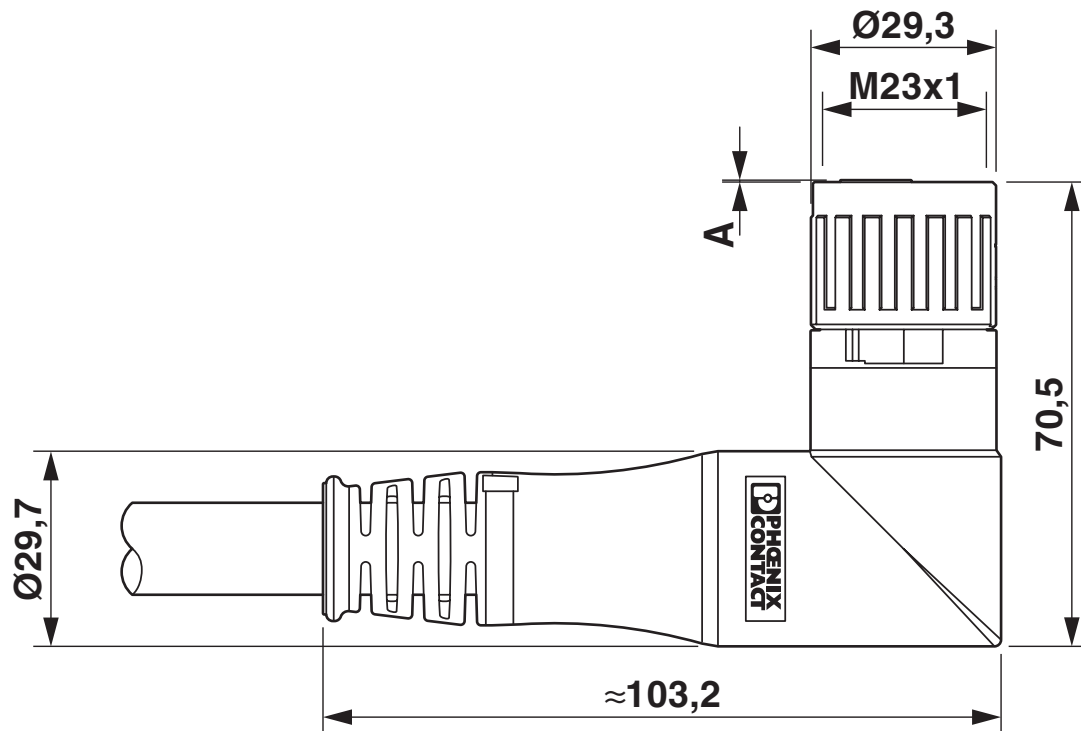

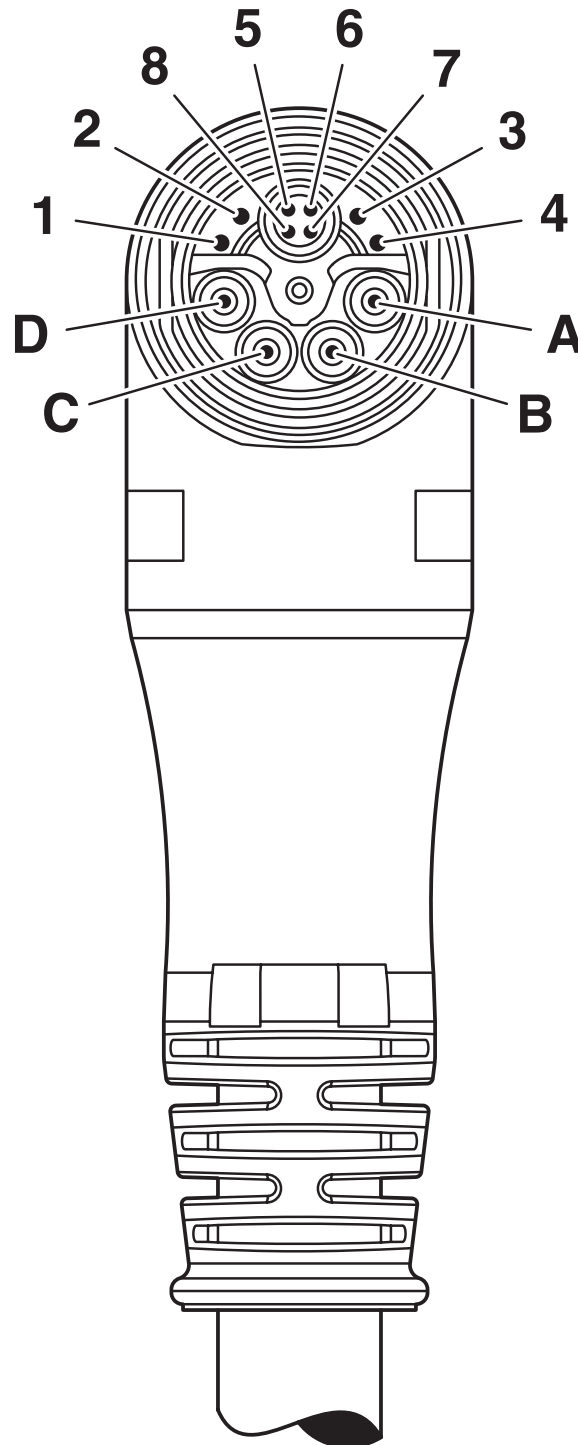

Cable outlet direction

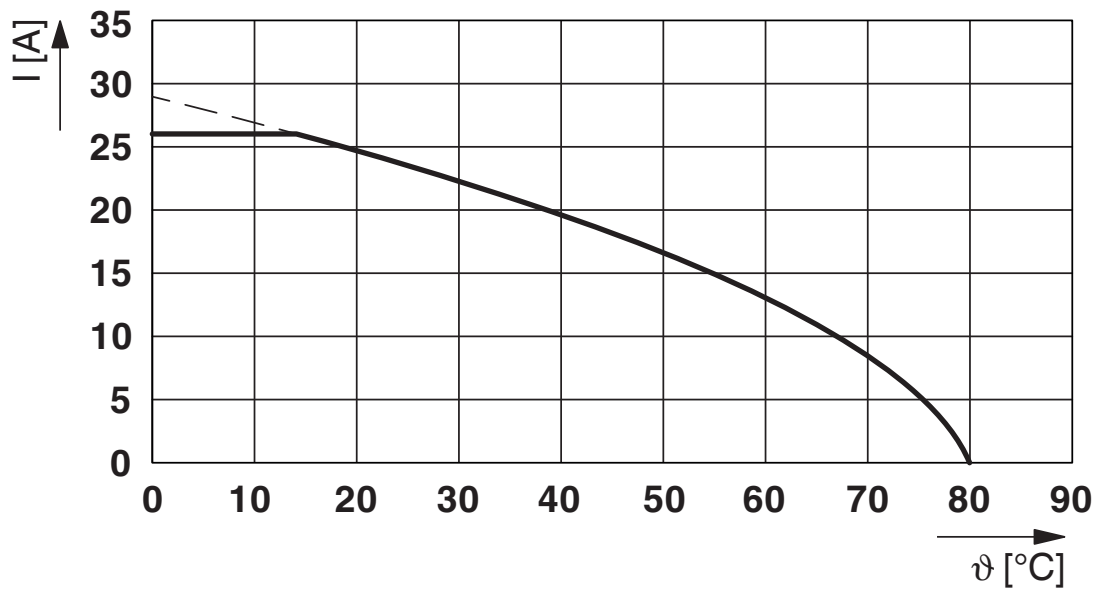

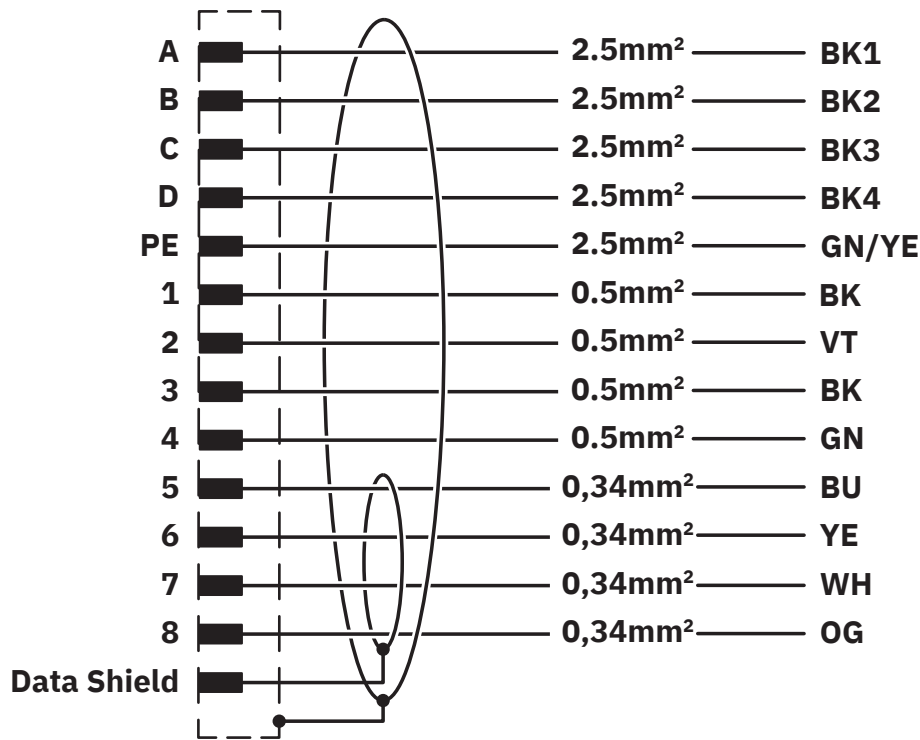

Circuit diagram



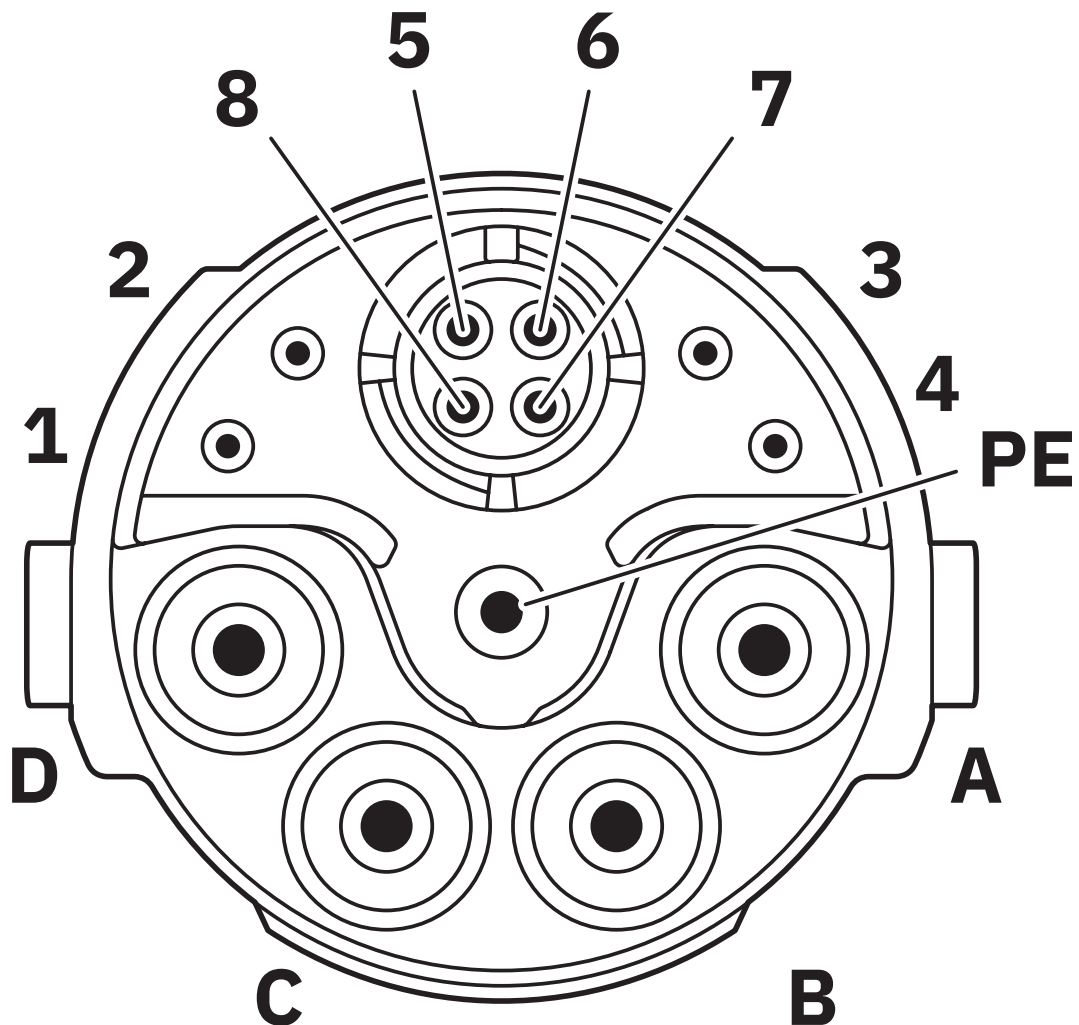
Contact assignment of M23 plugs/sockets
