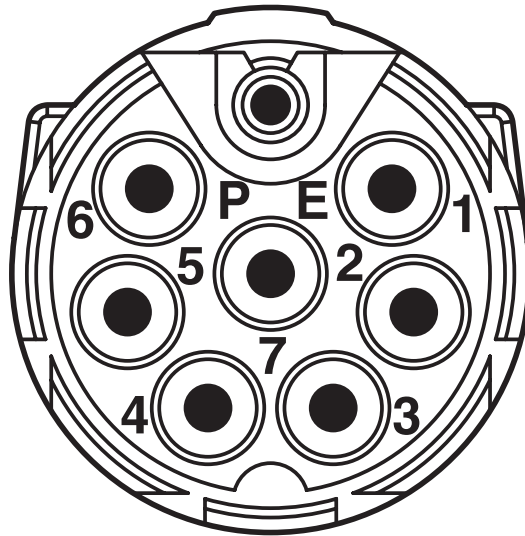

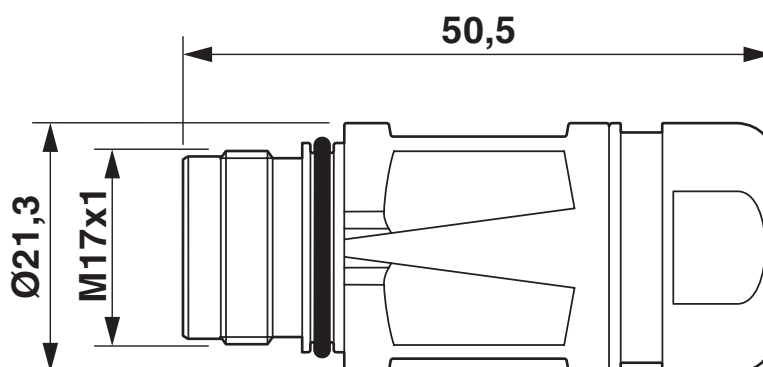

Dimensional drawing



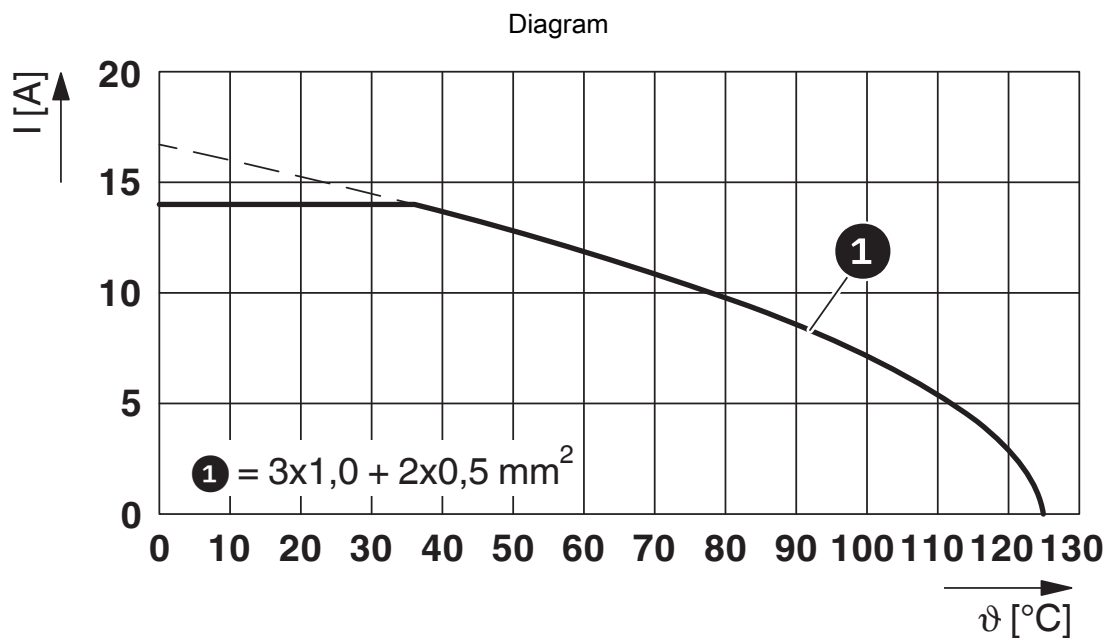
