
General information

Description of the product	The main purpose of the product is to switch on and off electrical power supply of a downstream installation with an electrical and/or mechanical control.
Functional unit	Switch on and off during 20 years electrical power supply of a downstream installation with an electrical and/or mechanical control. The functional unit is characterized by a type 3 NO, a control circuit voltage 220V AC, a power circuit voltage 300V DC/1000V AC and a rated operational current 150A AC-3.


