Adaptation of technical data of timing relay ETR4 and thermistor overload relay EMT6 and the resulting exchange of your inventory

Dear Sir or Madam,

As you probably know, the transition periods of DIN-Standards change expired as follows:

- "Thermistor overload relay - DIN EN 60947-8" with effect from 22nd June 2014
- "Timing relay - DIN EN 61812-1" with effect from 29th June 2014

We have reduced the rated operational voltage U_e for the devices with multi-voltage power supply from currently 400V to 300V and issued a new CE declaration of conformity accordingly. This change is marked on the devices as well as on the packaging with immediate effect.
