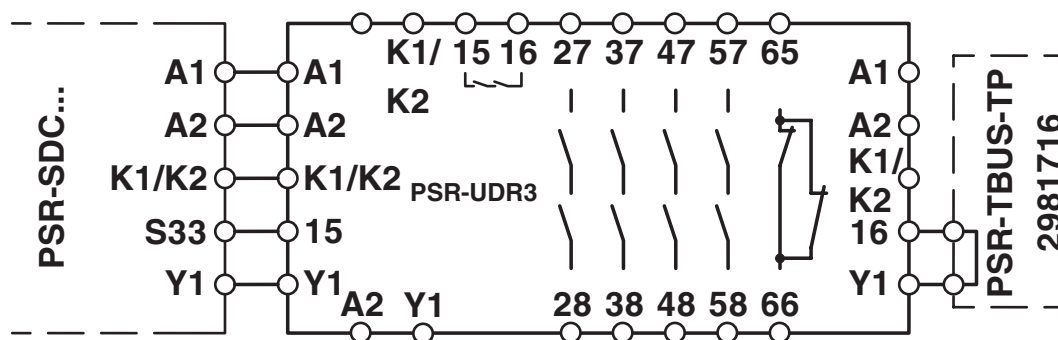

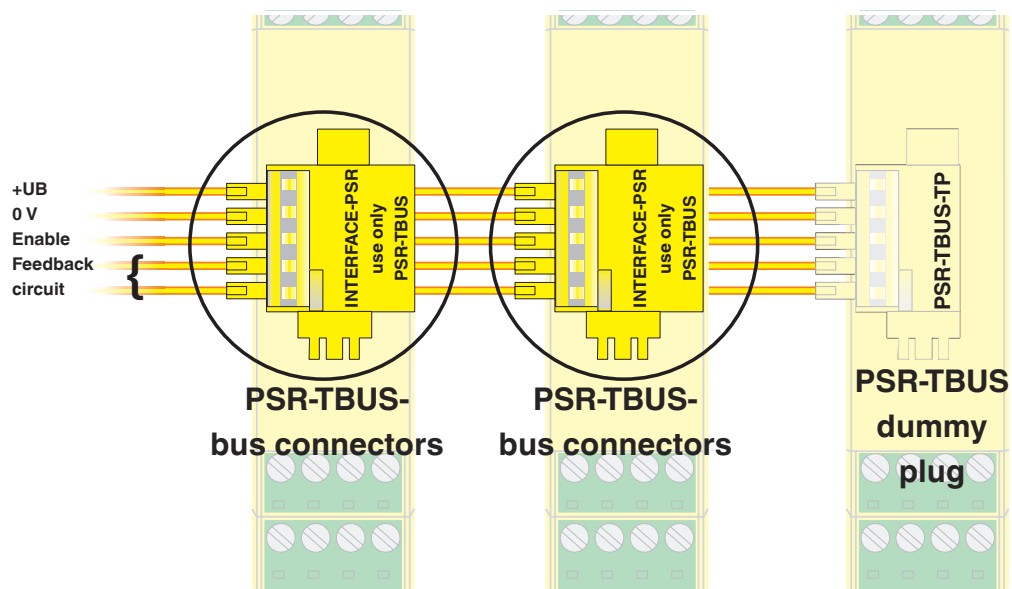

Connection diagram

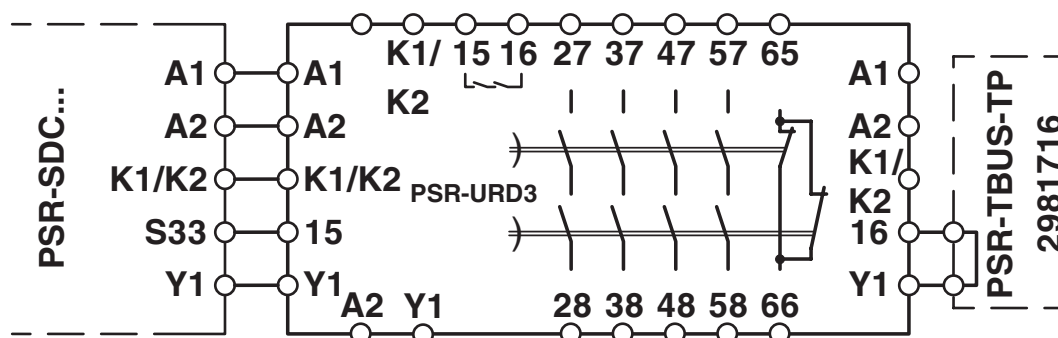

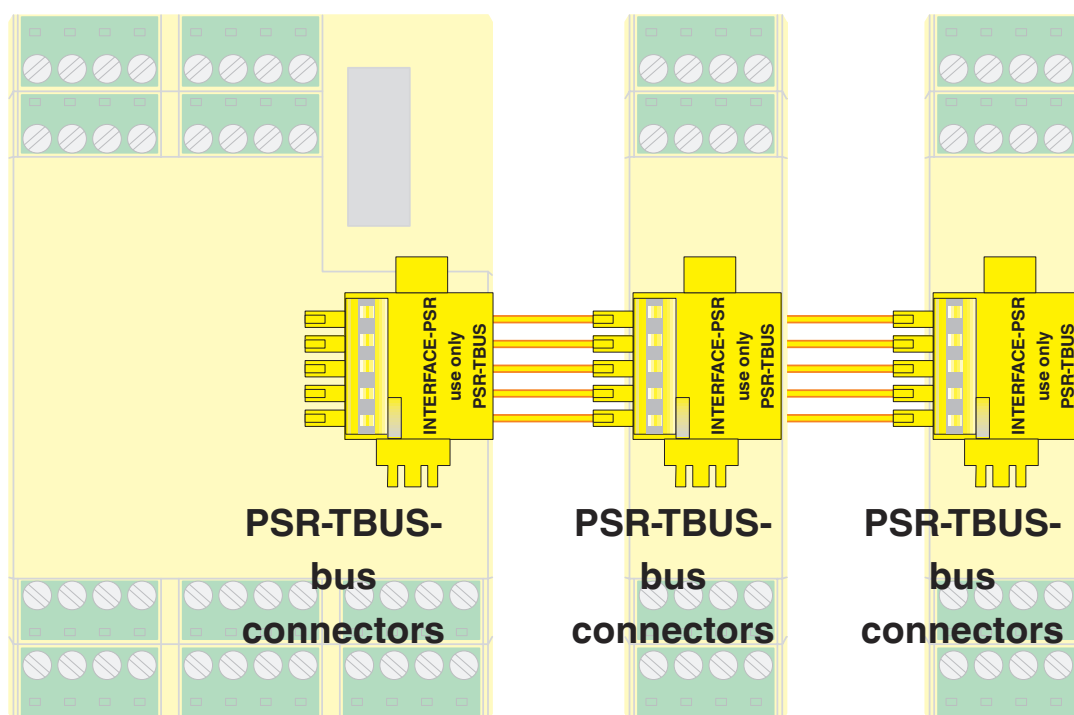
