Instructions for use of the MASQUE 63612

Description:

Mask in pigmented split cowhide leather, chrome-tanned, can be folded into a wallet, closure with self-gripping strips, equipped with a zipper box to adapt ECHELON 11 protection filters according to EN 169.

A sewn elastic band holds the mask on the head.

Sewn with 100% aromatic polyamide thread tex-theoretical 88.

Length flat: 270 mm Width flat: 287 mm

Recommendations:

Mask designed to adapt protective filters with or without guard glasses or reinforcement lenses, 105 x 50 mm, in compliance with standards EN 166, EN 169, EN 175 and following the recommendations of the protection manufacturer.

To protect the eyes and face part of the operator's head against harmful optical radiation and against other specific risks due to the usual welding, cutting or other related techniques, except laser welding.

Warnings:

Filter eyepieces made of reinforced mineral glass should only be used in conjunction with a suitable reinforcement eyepiece.

Scratched or damaged eyepieces should be replaced.

<u>Usage time:</u> As soon as you notice the slightest wear of one of the materials, replace the worn part. Expiry date: 5 years from the date of manufacture indicated on the mask.

Assembly:

Unfold the mask, insert the filter suitable for the desired operation into the housing, put it on and make sure that your eyes are well protected.

Do not start welding until this operation is completed.
