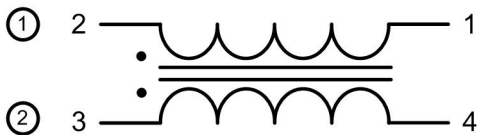
B Recommended hole pattern: [mm]

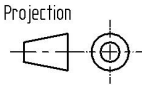

Common Mode

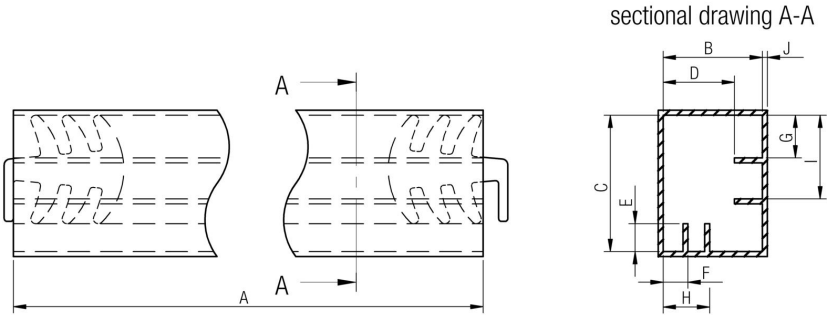


Differential Mode

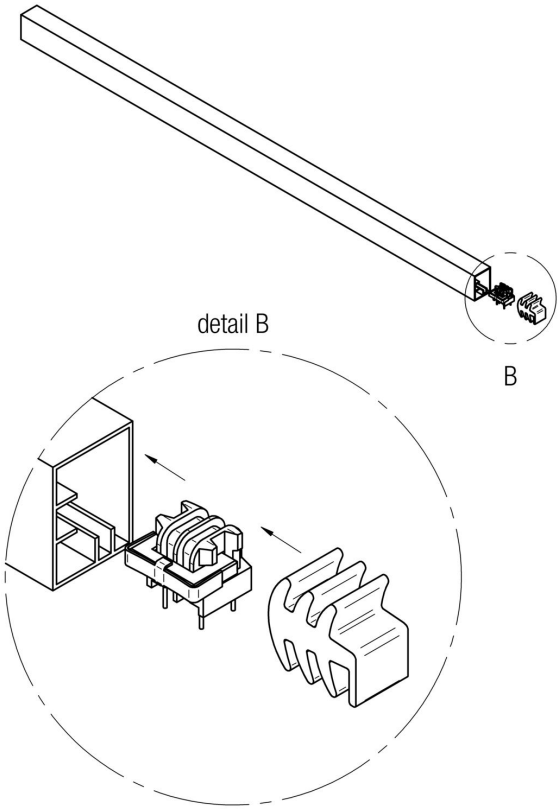
