The Transient Voltage Suppressor series offers a choice of Working Peak Reverse Voltage from 5 V up to 43 V. Typical fast response times are less than 1.0 picosecond from 0 V to Breakdown Voltage.

Bourns® Chip Diodes are easy to handle with standard pick and place equipment and the flat configuration minimizes roll away.






**Pulse Waveform** 




**Pulse Rating Curve** 





Maximum Non-Repetitive Surge Current



#### **Typical Junction Capacitance**








