The apron is secured by straps and counter-straps riveted at the waist and around the neck using the same process.
Taille : Unique

Recommendations :

Welding, grinding, sandblasting. Depending on the class indicated.
The garment offers protection against limited flame propagation, small splashes of molten metal, radiant heat and accidental short-term electrical contact.

Protection limits :

Type of protective clothing used during welding and related techniques class 2.

THIS garment must be used properly closed and tightened.

Do not use when handling chemicals or liquids.

For complete protection against the hazards encountered by welders, PPE covered by other standards should be worn in addition, to protect the head, face, hands and feet.

Packaging, care & maintenance, storage :

The garment is packaged individually. No special care is recommended.
Store in a cool, dry, well-ventilated place, away from light.

Before re-use, check the garment visually for defects, holes, tears and wear. If the wearer suffers symptoms similar to sunburn, UVB rays are being transmitted. The garment should be repaired or replaced, and additional, more resistant protective layers should be considered.
