








Permissible Pulse Handling Capability




Permissible Pulse Handling Capability

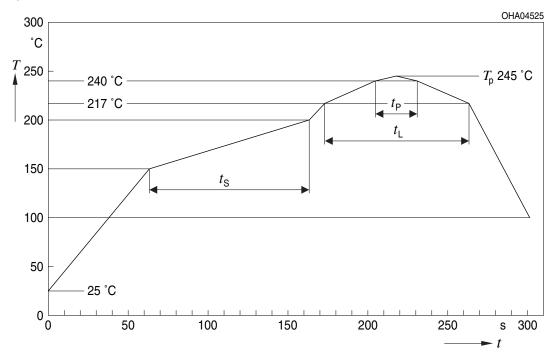
Component Location on Pad
