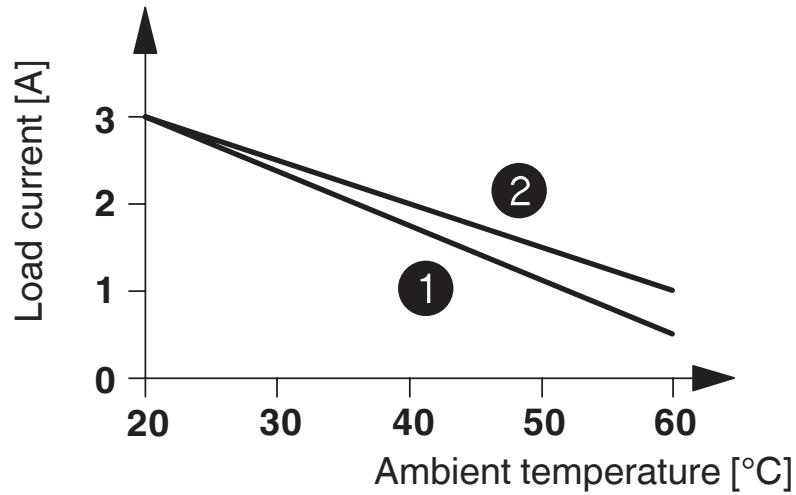

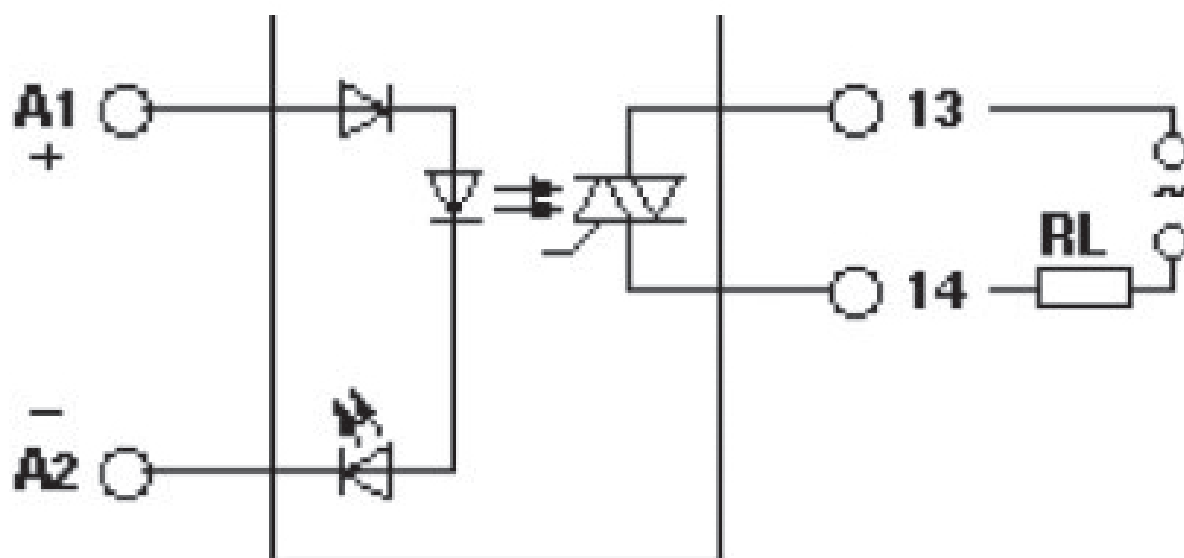

Circuit diagram

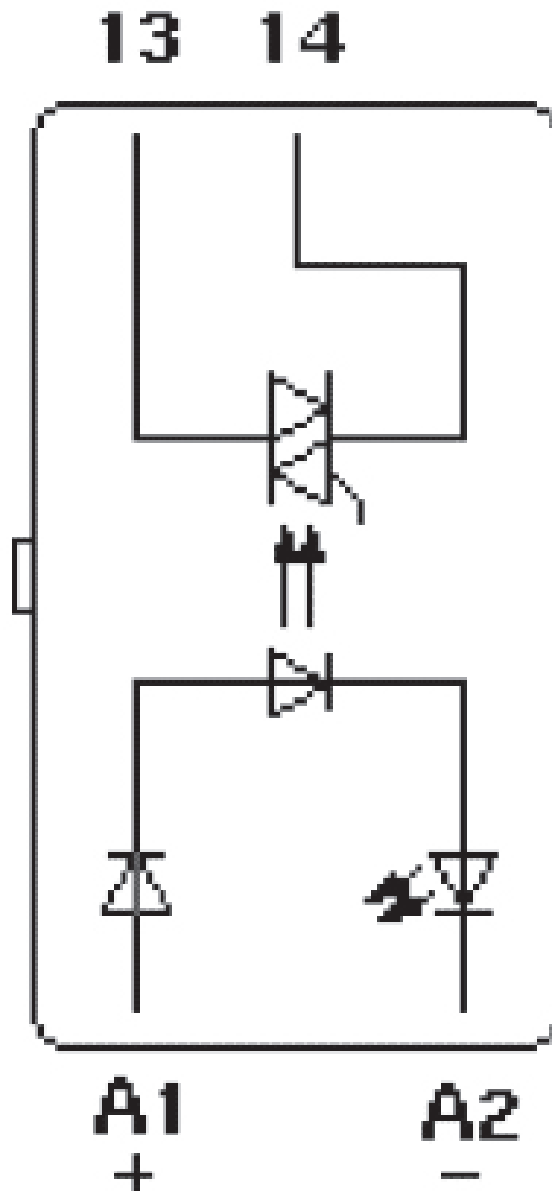
