

CARTRIDGE STORAGE

To prevent condensation and for long life, the cartridge should only be operated or stored in the following conditions.

> **OPERATION** 40°C 104° F

> > 50°F

STORAGE 32°C 90°F OPERATION AND STORAGE 20% to 80%

CARTRIDGE HANDLING

Handle the cartridge carefully. The cartridge may be damaged if it is dropped. Labels should go only in the Front Slide Slot as shown in the diagram.
