







RELATIVE INTENSITY Vs. WAVELENGTH










CIRCUIT DESIGN NOTES



Reflow Soldering Profile For Lead-free SMT Process.




- NOTES:

 3.Number of reflow process shall be 2 times or less.



Tape Specifications (Units: mm)


