

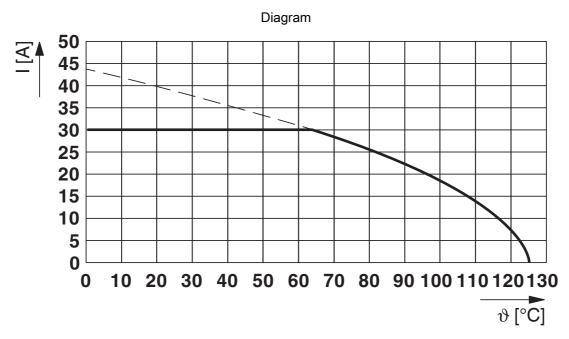

Connector pin assignment




