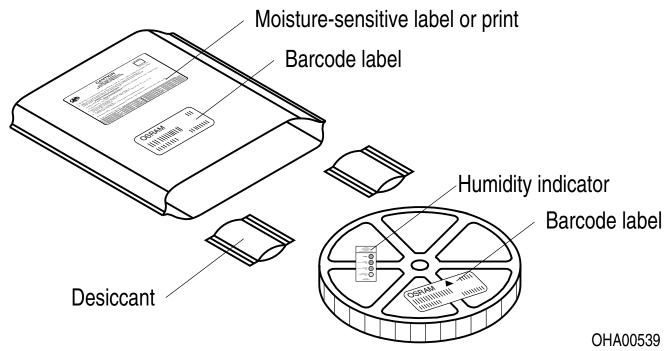

Notes
