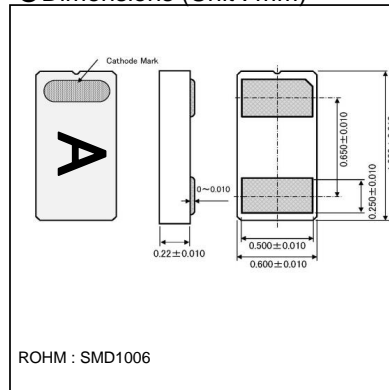

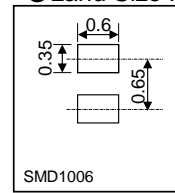

Silicon epitaxial planar type

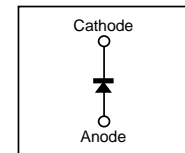

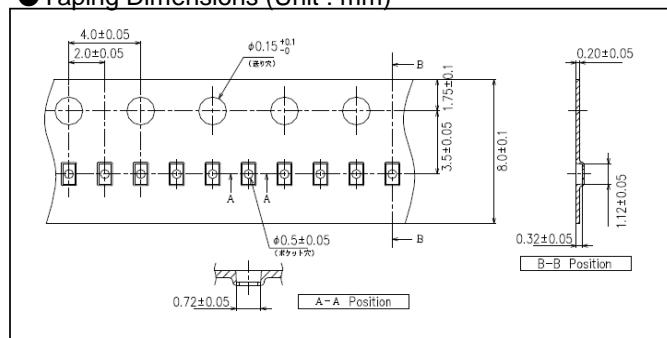
● Land Size Figure (Unit : mm)

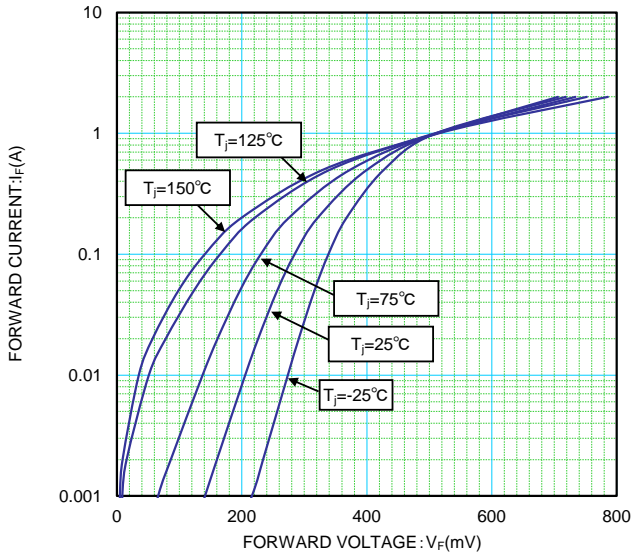

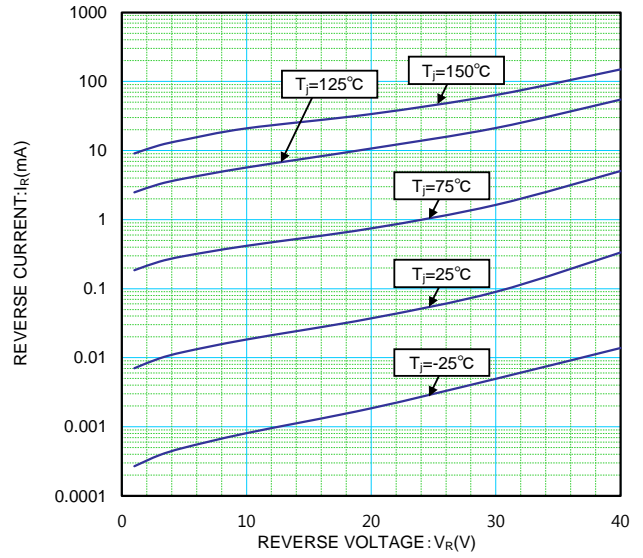

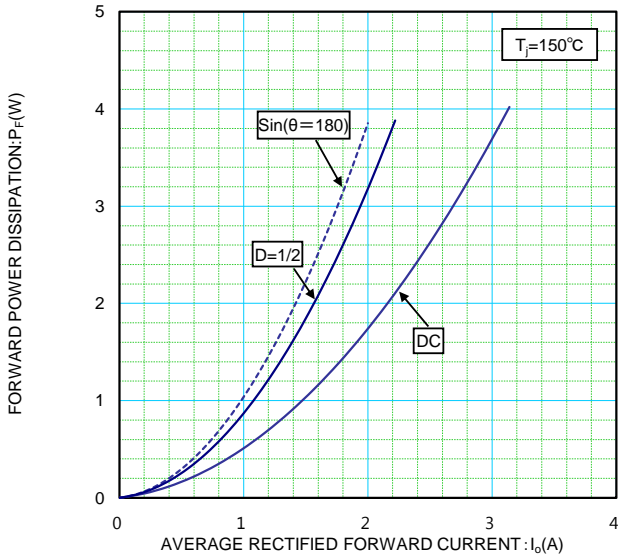
●Electrical Characteristic Curves



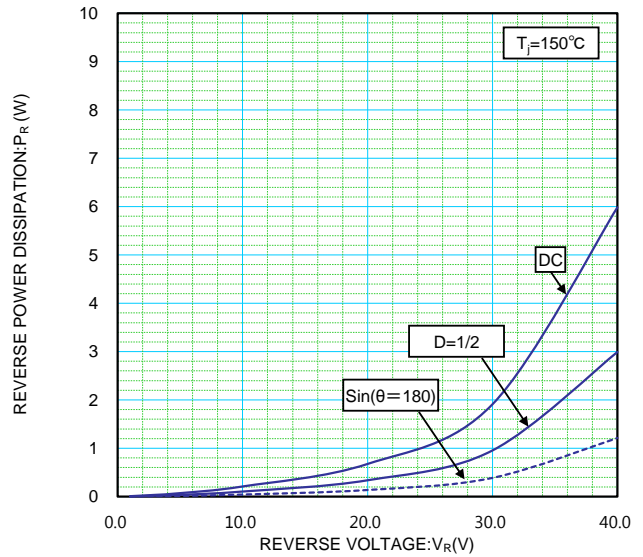
**V<sub>F</sub>-I<sub>F</sub> CHARACTERISTICS**



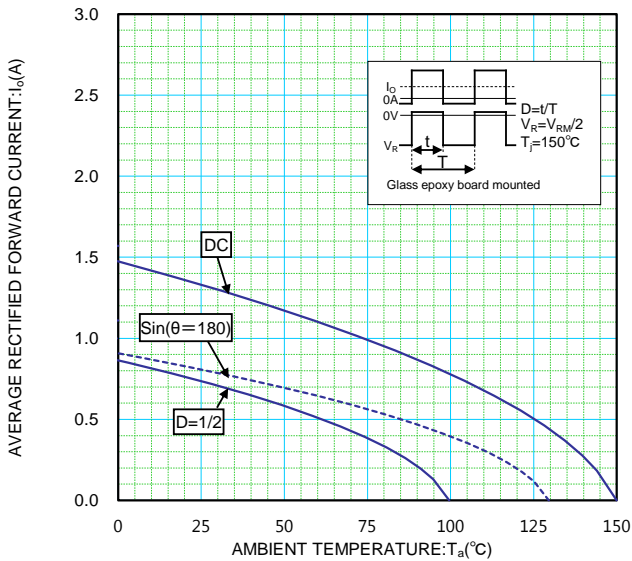
**V<sub>R</sub>-I<sub>R</sub> CHARACTERISTICS**



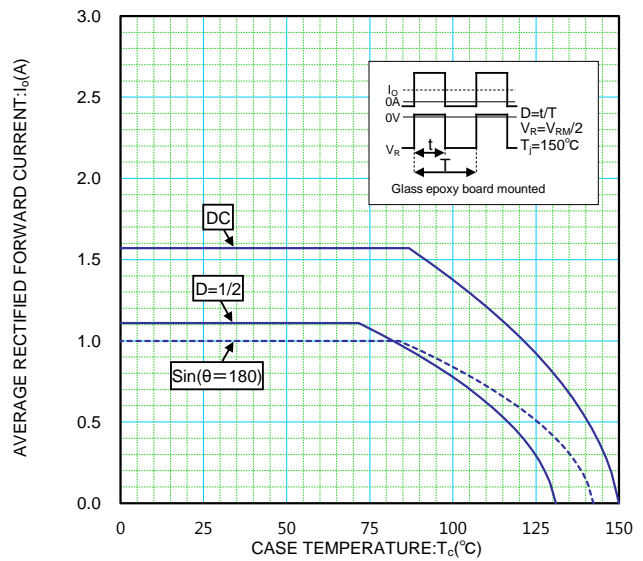
**I<sub>o</sub>-P<sub>F</sub> CHARACTERISTICS**

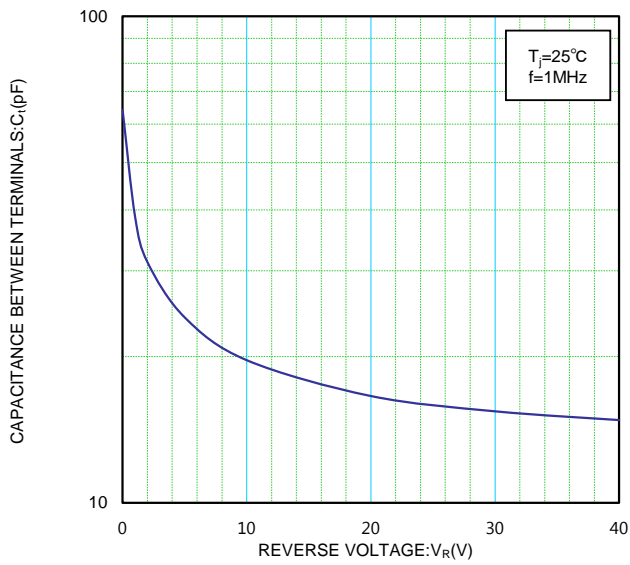


**DERATING CURVE ( $I_o$ - $T_a$ )**

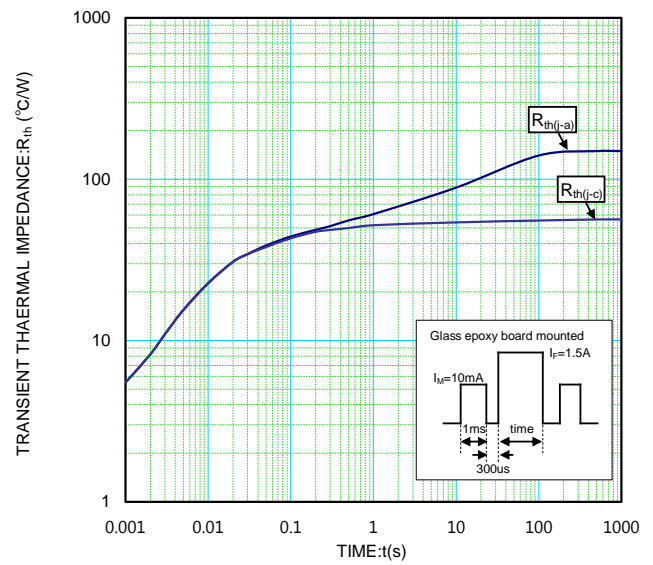


**DERATING CURVE ( $I_o$ - $T_c$ )**

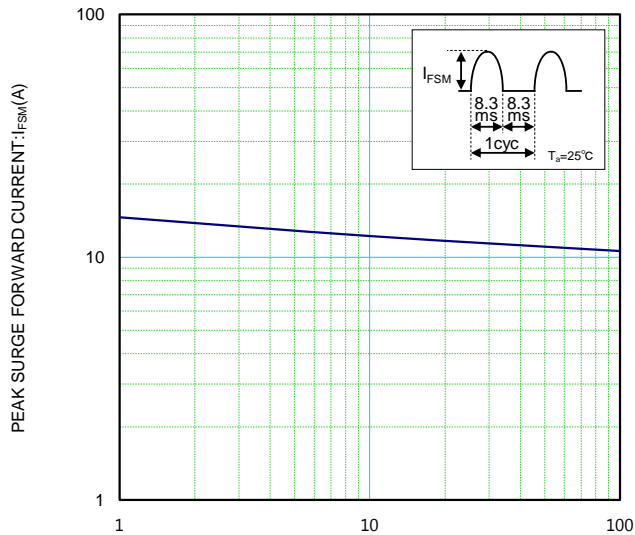
●Electrical Characteristic Curves



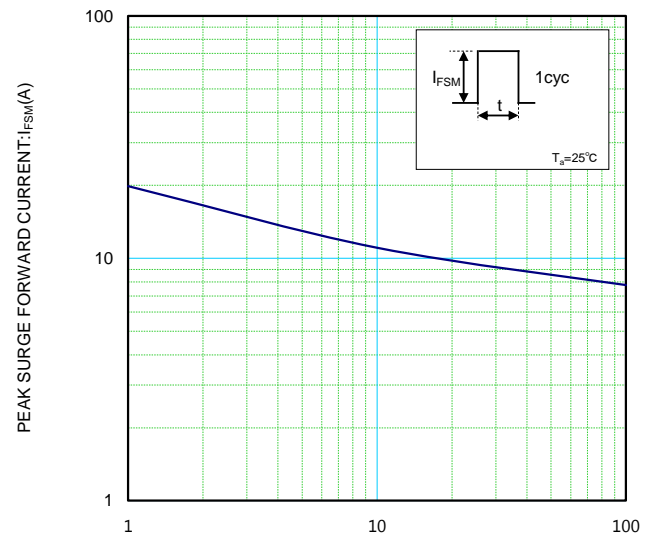
**V<sub>R</sub>-C<sub>t</sub> CHARACTERISTICS**

- When a highly active halogenous (chlorine, bromine, etc.) flux is used, the residue of flux may negatively affect product performance and reliability.
- In principle, the reflow soldering method must be used on a surface-mount products, the flow soldering method must be used on a through hole mount products. If the flow soldering method is preferred on a surface-mount products, please consult with the ROHM representative in advance.
