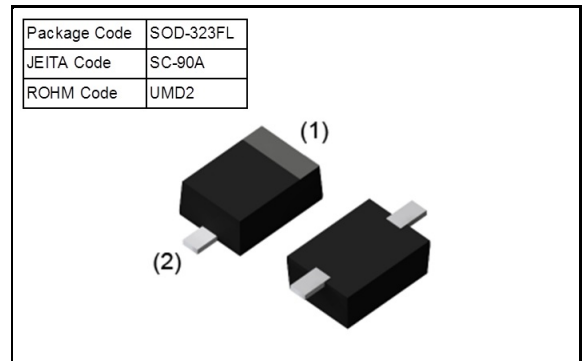

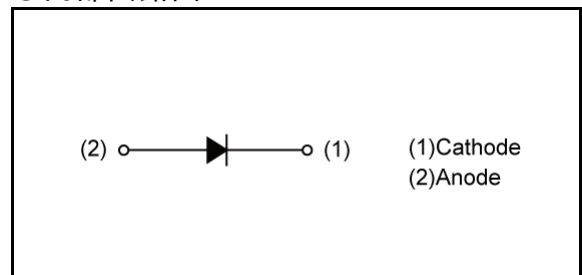
### 使用上の注意

### ● 外形図



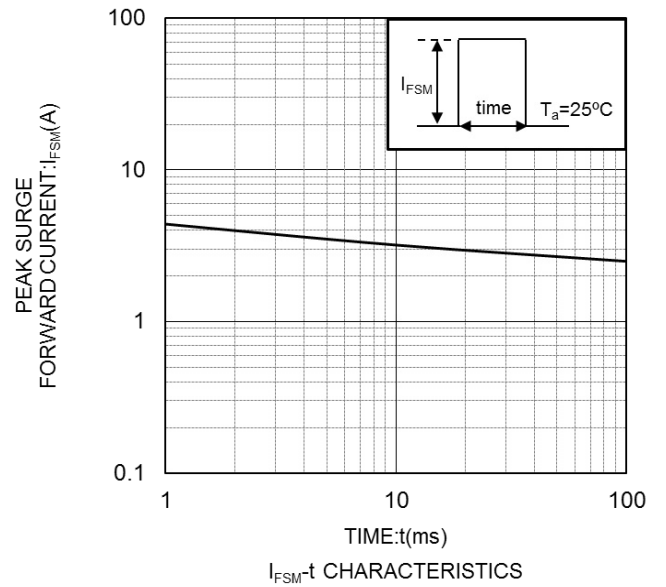
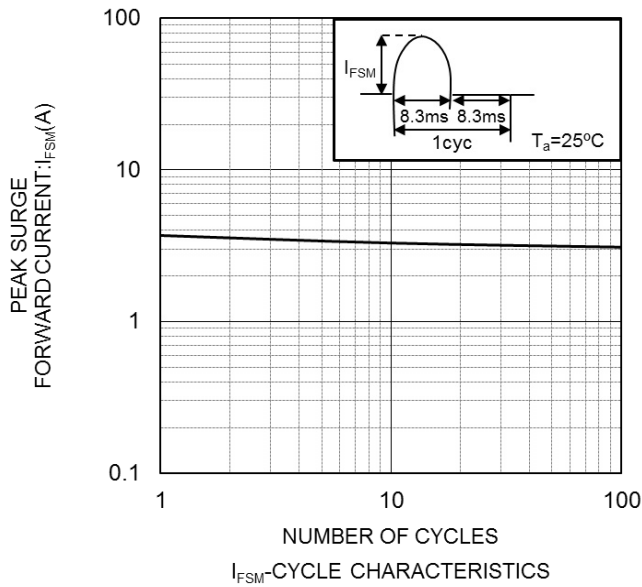
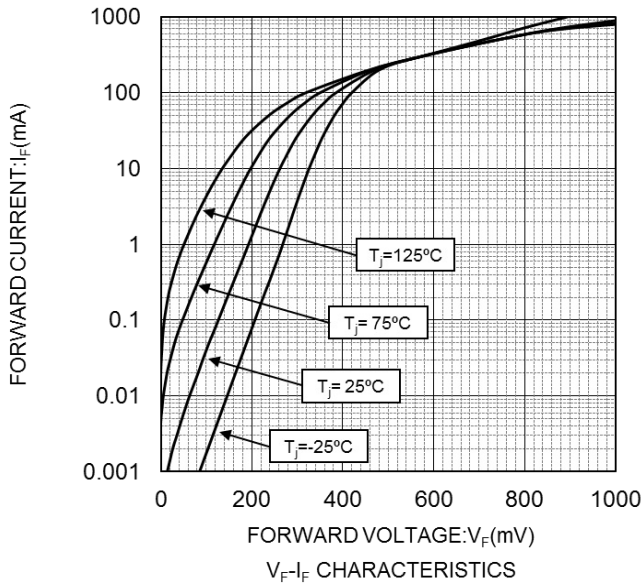

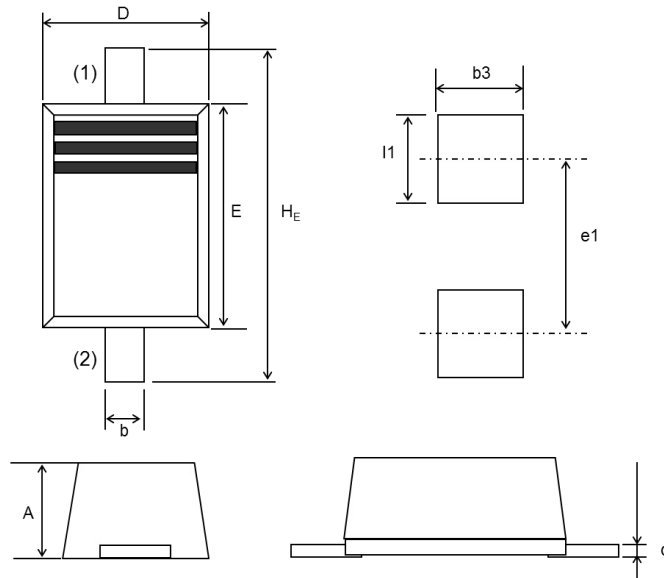
