#### 1 Introduction

These Website Terms and Conditions apply in full force and effect to your use of this Makita (UK) Ltd.'s Website and by using this Website, you explicitly accept all terms and conditions contained here in full. You must not use this Website, if you have any objection to any of these Website Terms and Conditions.

## 2 Information about our use of Cookies

This Website uses cookies. By using this Website and agreeing to these terms of use you consent to our use of cookies on this Website.

- 2.1 Our website uses cookies to distinguish you from other users of our website. This helps us to provide you with a good experience when you browse our website and also allows us to improve our site. By continuing to browse the site, you are agreeing to our use of cookies.
- 2.2 A cookie is a small file of letters and numbers that we store on your browser or the hard drive of your computer if you agree. Cookies contain information that is transferred to your computer's hard drive.

## 2.3 - We use the following cookies:

- **Strictly necessary cookies** These are cookies that are required for the operation of our website. These cookies make sure that no cookies are placed without your consent and also ensure you do not have to confirm cookie preferences again at each new page on our website. These strictly necessary cookies expire at the end of your browser session. They do not remain on your device beyond your session.
