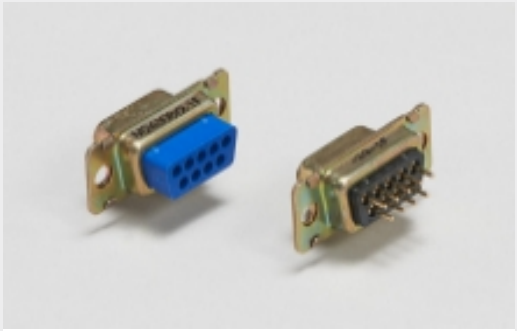
Connector Strain Relief(2)

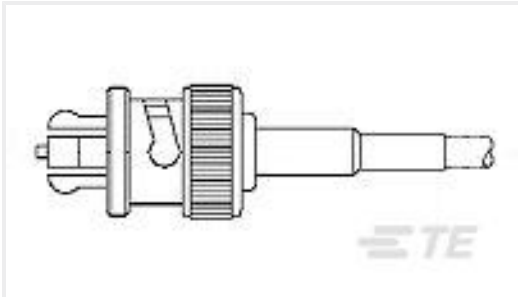

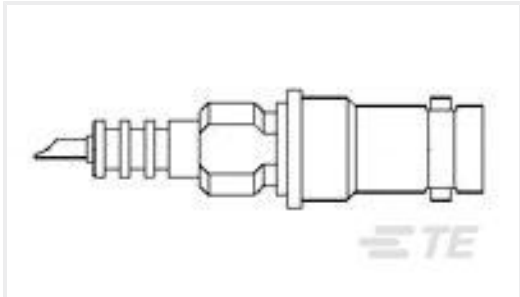

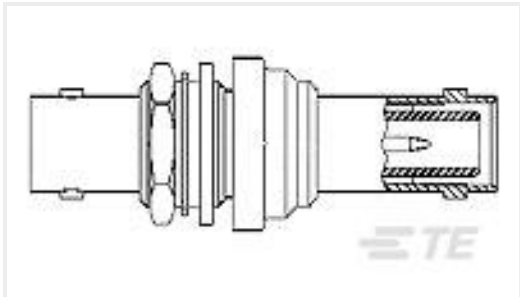
