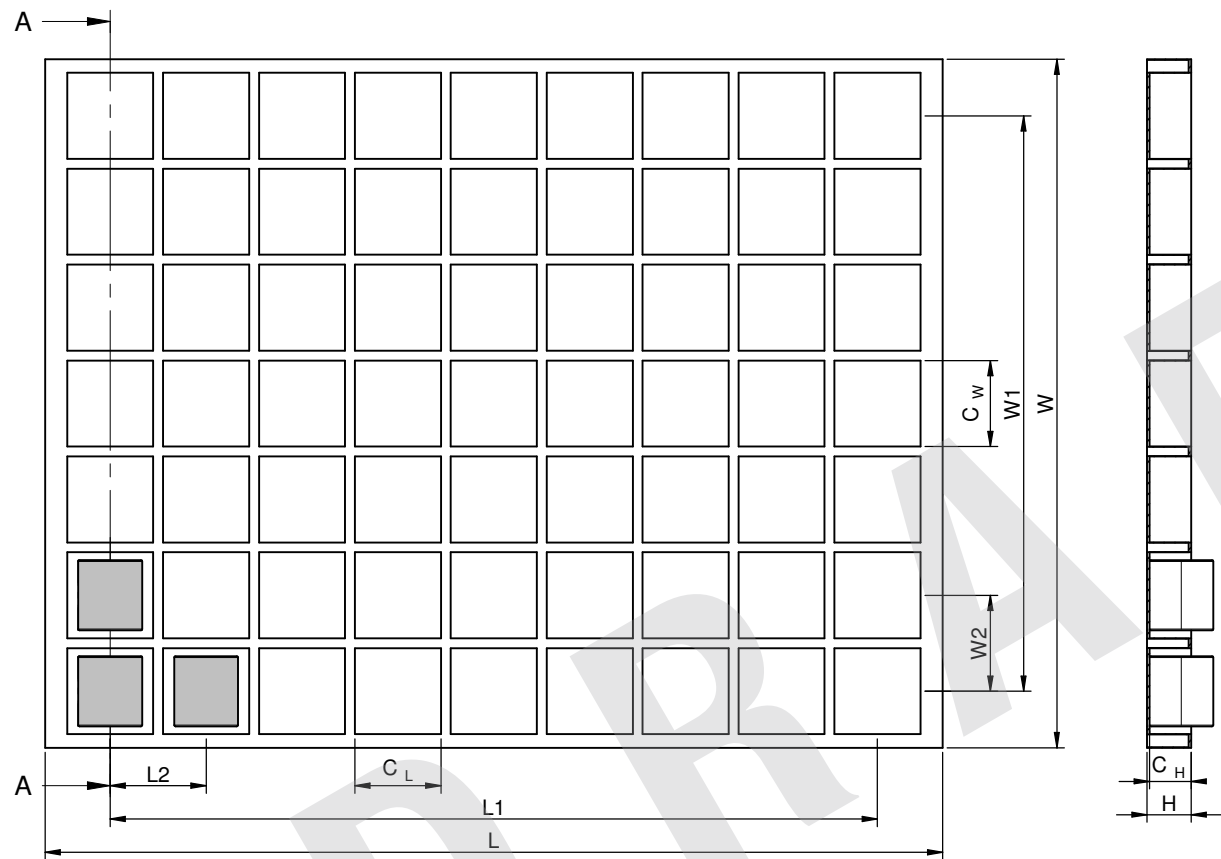
Typical Impedance vs. Frequency:

Product specific:

- Cleaning and Washing:

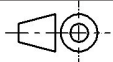
Packaging:

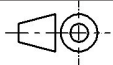
