## **Recommended Land Pattern: [mm]**











# **Peak Pulse Power and Current Derating:**




# **Steady State Power Dissipation Derating:**









### **Typical Junction Capacitance:**



After the potting material is cured, the body and termination of the product have to be checked if any reduced electrical or mechanical functions or destructions have occurred.

Signals operated continuously with a high ratio of direct-current voltage might have an influence on the product life time.


#### **Product specific:**
