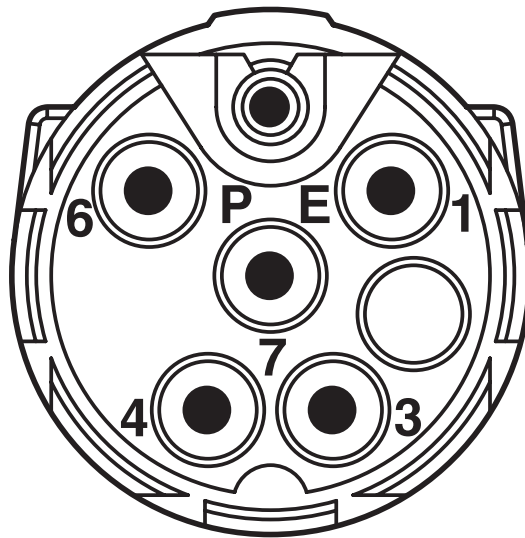

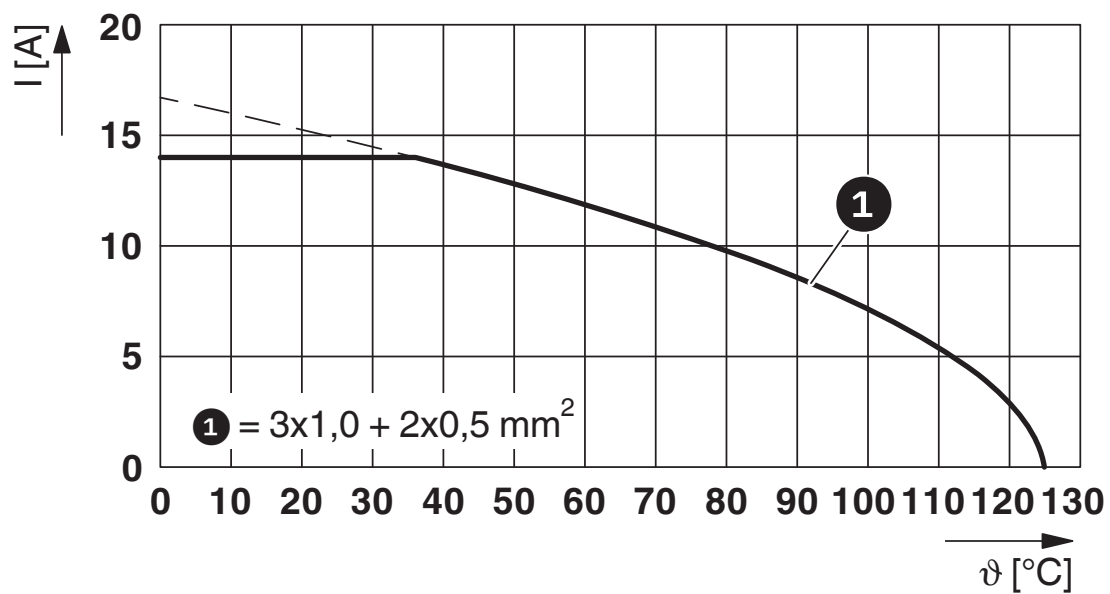

I = current strength, ϑ = ambient temperature, 3x 14 A + 2x 2 A constant

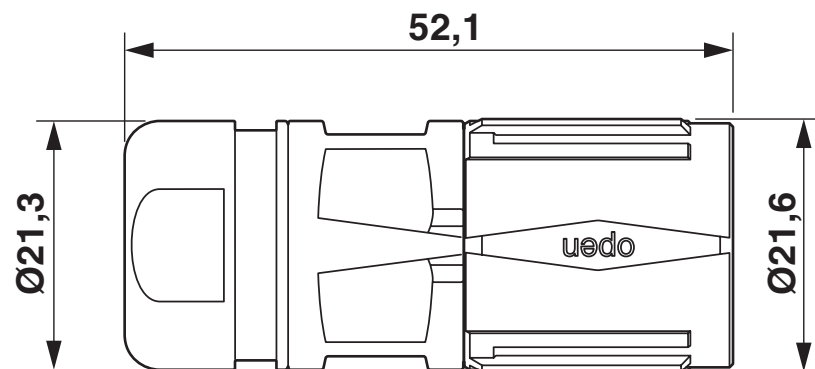
