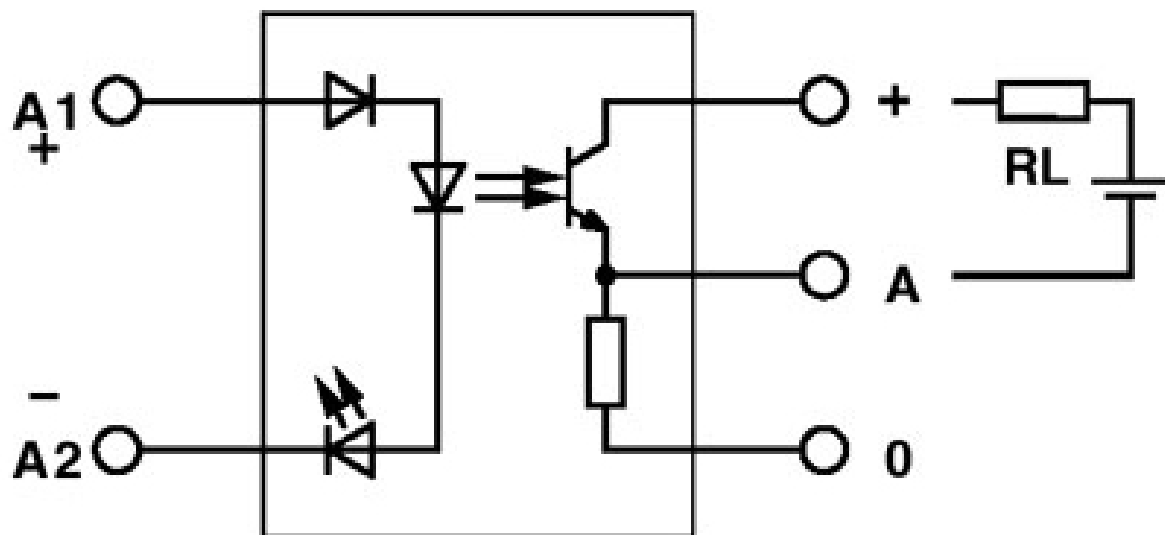

Output: 2-conductor, floating, negative switching

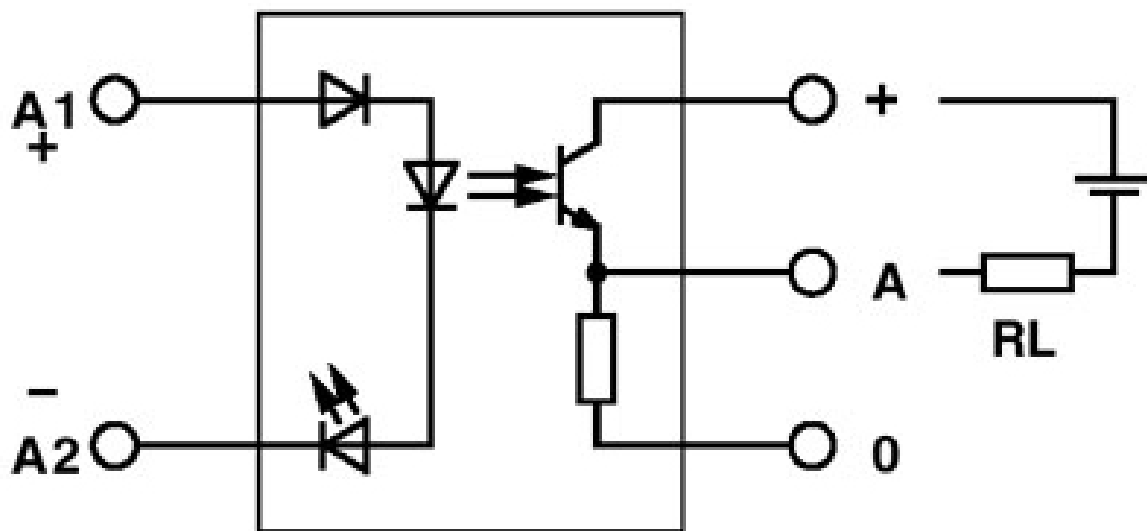

Output: 2-conductor, floating, positive switching

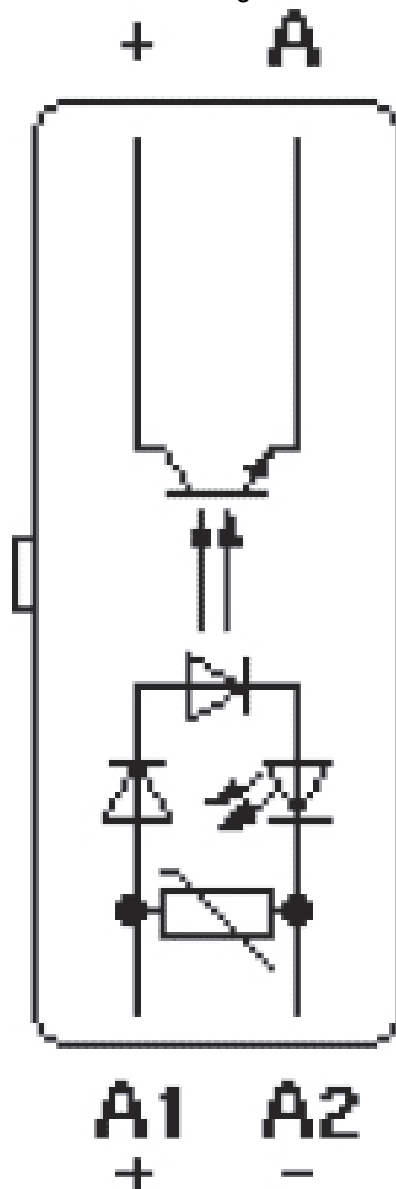
