



Fig.3 DC Current Gain vs. Collector Current(I)





Fig.4 DC Current Gain vs. Collector Current(II)

Fig.6 Collector-Emitter Saturation Voltage vs. Collector Current(II)




Fig.7 Base-Emitter Saturation Voltage vs. Collector Current





Fig.8 Gain Bandwidth Product vs. Emitter Current



EMITTER CURRENT : I_E [mA]




Fig.9 Emitter input capacitance vs.


Emitter-Base Voltage

Collector output capacitance vs.











SWITCHING TIME TEST CIRCUIT


