







Relative Luminous Intensity ⁷⁾






Permissible Pulse Handling Capability






Electrical Internal Circuit



Unused remaining LEDs should be protected from environment due to silver plated soldering terminal. In order to maintain solderability it is recommended to protect the silver plated solder terminals from corrosive environment before soldering. For superior solder joint connectivity results we recommend soldering under standard nitrogen atmosphere.

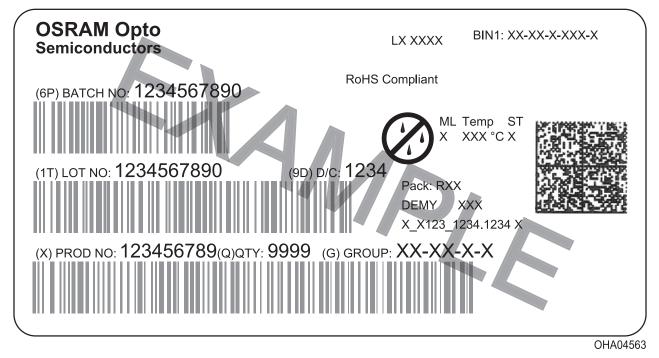
