


High Intensity LED in Ø 3 mm Tinted Diffused Package







Fig. 2 - Relative Luminous Intensity vs. Angular Displacement

Fig. 3 - Forward Current vs. Forward Voltage




Fig. 4 - Rel. Luminous Intensity vs. Ambient Temperature




Fig. 5 - Change of Forward Voltage vs. Ambient Temperature




Fig. 6 - Relative Luminous Intensity vs. Forward Current






Fig. 7 - Relative Intensity vs. Wavelength


