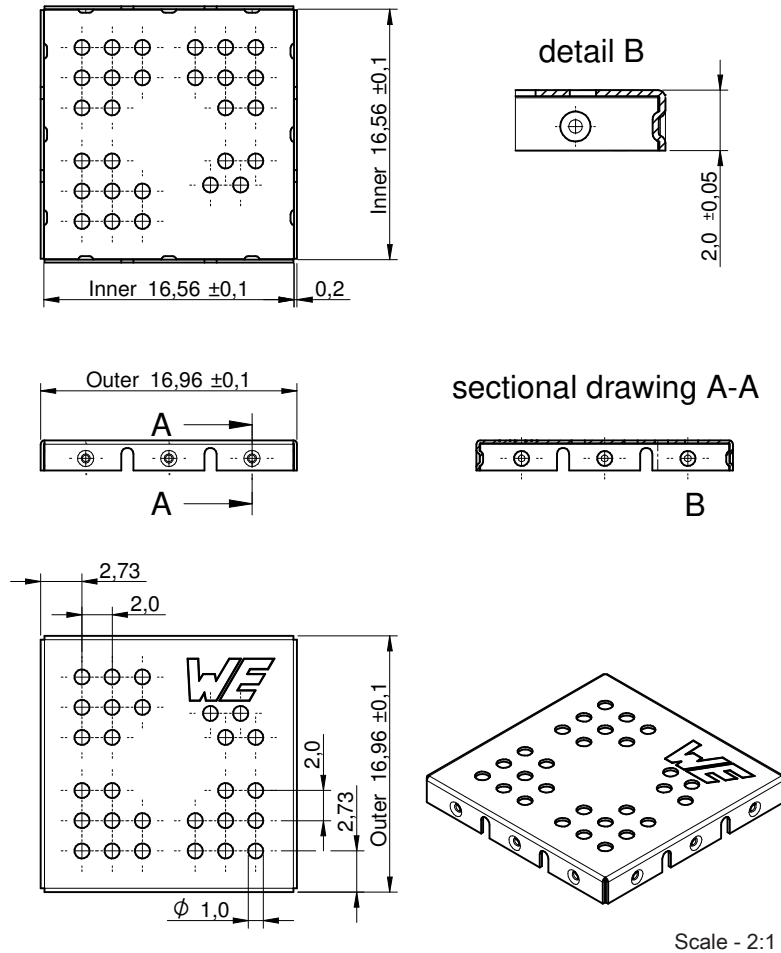
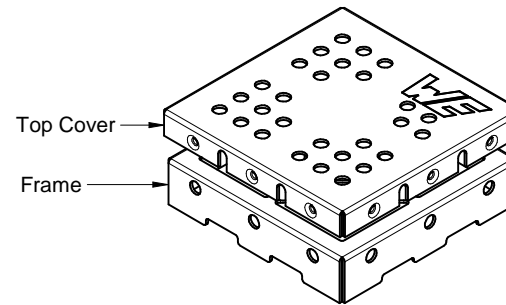

Assembly with SMD Frame:





6. Product Life Cycle



