1 About this document

1.1 Function

This operating instructions manual provides all the information you need for the mounting, set-up and commissioning to ensure the safe operation and disassembly of the safety switchgear. The operating instructions must be available in a legible condition and a complete version in the vicinity of the device.

1.2 Target group: authorised qualified personnel

All operations described in this operating instructions manual must be carried out by trained specialist personnel, authorised by the plant operator only.

Please make sure that you have read and understood these operating instructions and that you know all applicable legislations regarding occupational safety and accident prevention prior to installation and putting the component into operation.

The machine builder must carefully select the harmonised standards to be complied with as well as other technical specifications for the selection, mounting and integration of the components.

1.3 Explanation of the symbols used

The safety switchgear must be exclusively used in accordance with the versions listed below or for the applications authorised by the manufacturer. Detailed information regarding the range of applications can be found in the chapter "Product description".

1.5 General safety instructions

The user must observe the safety instructions in this operating instructions manual, the country-specific installation standards as well as all prevailing safety regulations and accident prevention rules.

If multiple safety components are wired in series, the Performance Level to EN ISO 13849-1 will be reduced due to the restricted error detection under certain circumstances. The entire concept of the control system, in which the safety component is integrated, must be validated to EN ISO 13849-2.

There are no residual risks, provided that the safety instructions as well as the instructions regarding mounting, commissioning, operation and maintenance are observed.

2 Product description

2.1 Ordering code

This operating instructions manual applies to the following types:

Only if the information described in this operating instructions manual are realised correctly, the safety function and therefore the compliance with the Machinery Directive is maintained.

2.2 Special versions

For special versions, which are not listed in the order code below 2.1, these specifications apply accordingly, provided that they correspond to the standard version.

2.3 Destination and use

The safety switches are suitable for hinged guards, which need to be closed in order to ensure the necessary operational safety. The hinge safety switch is equipped with two switch inserts S1 and S2 with differentiated operating principle. When the safety guard is closed (starting position), switch insert S1 is not actuated and S2 is actuated. The hinges are not included in delivery.



The user must evaluate and design the safety chain in accordance with the relevant standards and the required safety level.

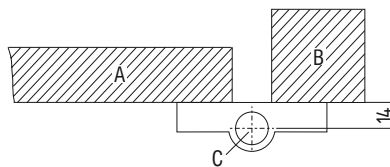
3 Mounting

3.1 General mounting instructions

Any mounting position. The hinge switch and the switch must be fitted so that the hinge switch and the switch are in alignment with the universal joint (execute the optimal setting by means of a continuity tester). The universal joint must be fixed in the switch and the hinge by means of the supplied spiral pin.

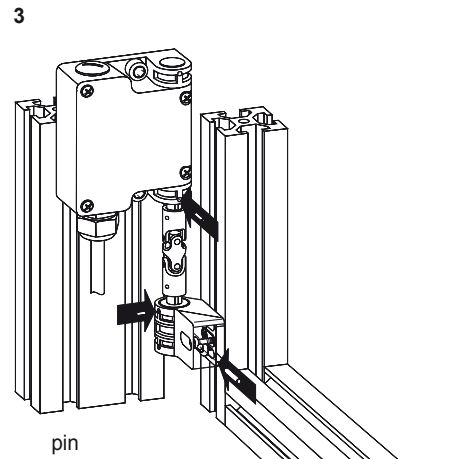
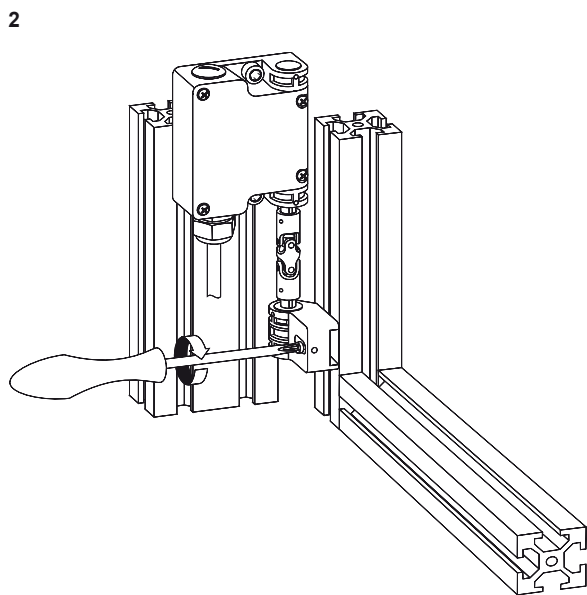
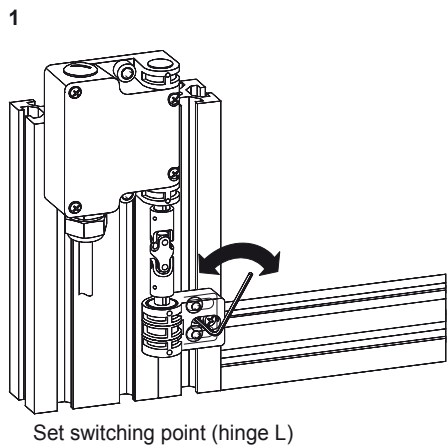
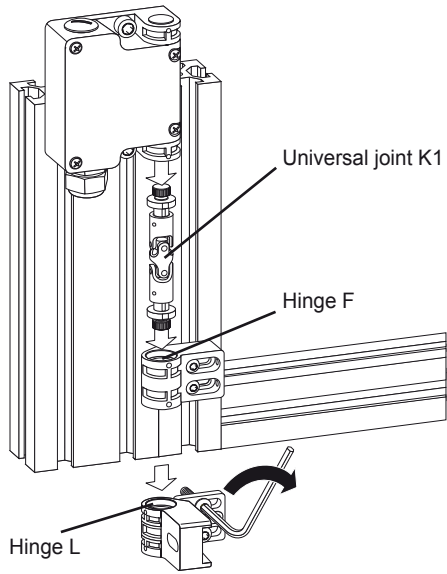


The distance of the door to the door hinge centre must be 14 mm.

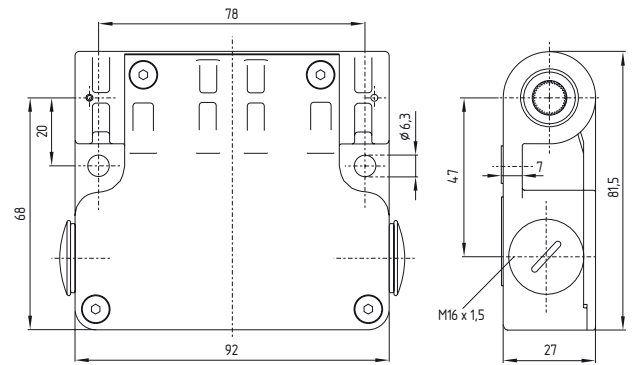


A = safety guard

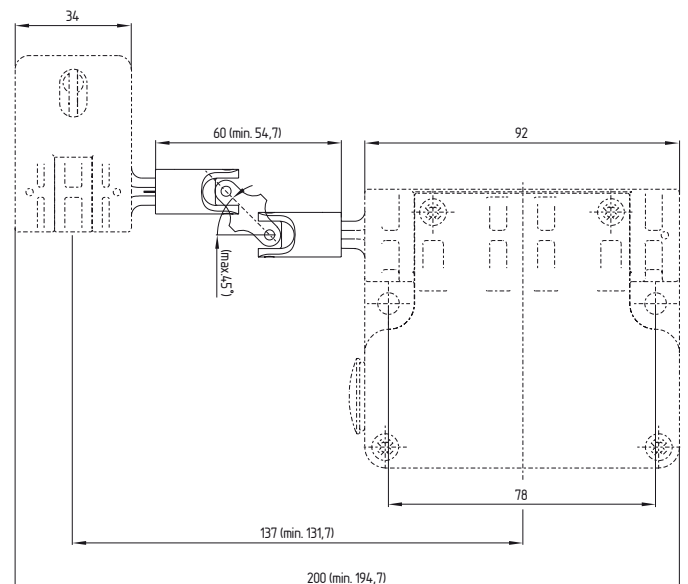

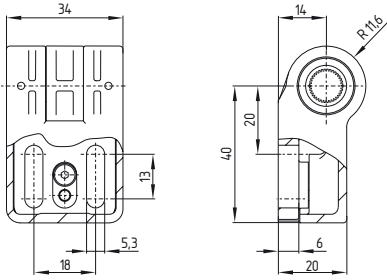


Hinge L is shown on the picture
Overall length with hinge F: 196 mm (min. 191.7 mm)

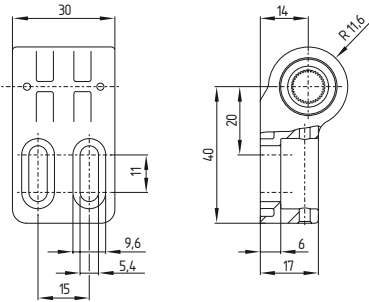
Universal joint K1

4 Electrical connection

4.1 General information for electrical connection

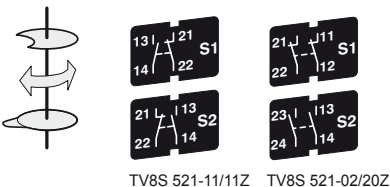


The electrical connection may only be carried out by authorised personnel in a de-energised condition.

For the cable entry, suitable cable glands with an appropriate degree of protection must be used. Non-used openings must be sealed by means of threaded plugs. Check the switch point setting by means of a multimeter prior to the wiring.

4.2 Contact variants

Contacts are shown with safety guard closed.



5 Set-up and maintenance

5.1 Functional testing

The safety function of the safety components must be tested. The following conditions must be previously checked and met:

1. Check the positive link between the shaft and the door hinge
2. Check for correct installation of the hinge safety switch
3. Check the switch enclosure for damage.
4. Check the integrity of the cable entry and connections

5.2 Maintenance

In case of correct installation in accordance with the above-described instructions, the component requires little maintenance.

A regular visual inspection and functional test, including the following steps, is recommended:

1. Check the positive link between the shaft and the door hinge
2. Check the switch enclosure for damage
3. Check for correct installation of the hinge safety switch
4. Remove particles of dust and soiling
- 5 Check cable entry and connections

Damaged or defective components must be replaced.

6 Disassembly and disposal



6.1 Disassembly

The safety switchgear must be disassembled in a de-energised condition only.

6.2 Disposal

The safety switchgear must be disposed of in an appropriate manner in accordance with the national prescriptions and legislations.
