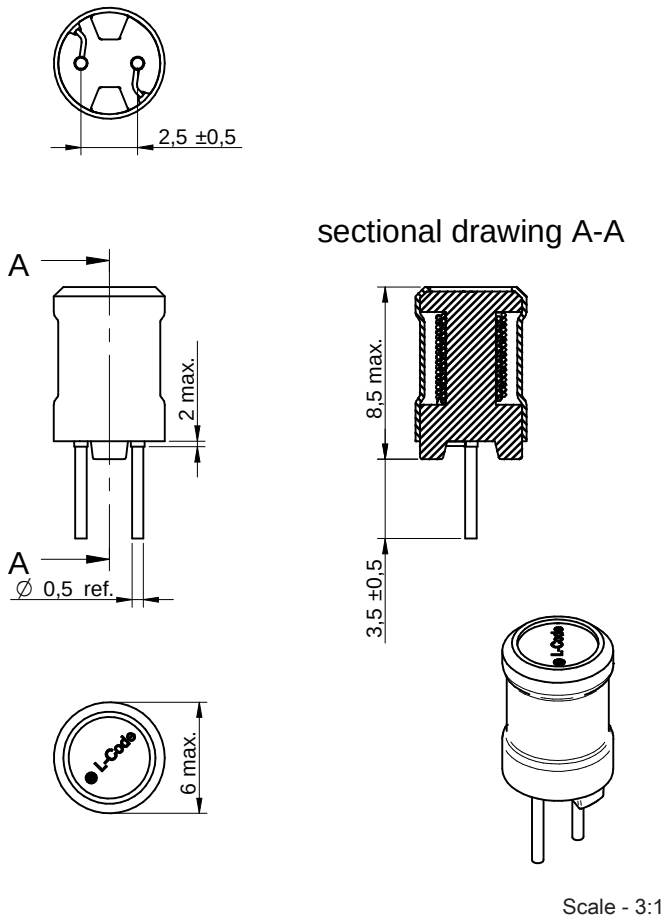

Typical Inductance vs. Current Characteristics:



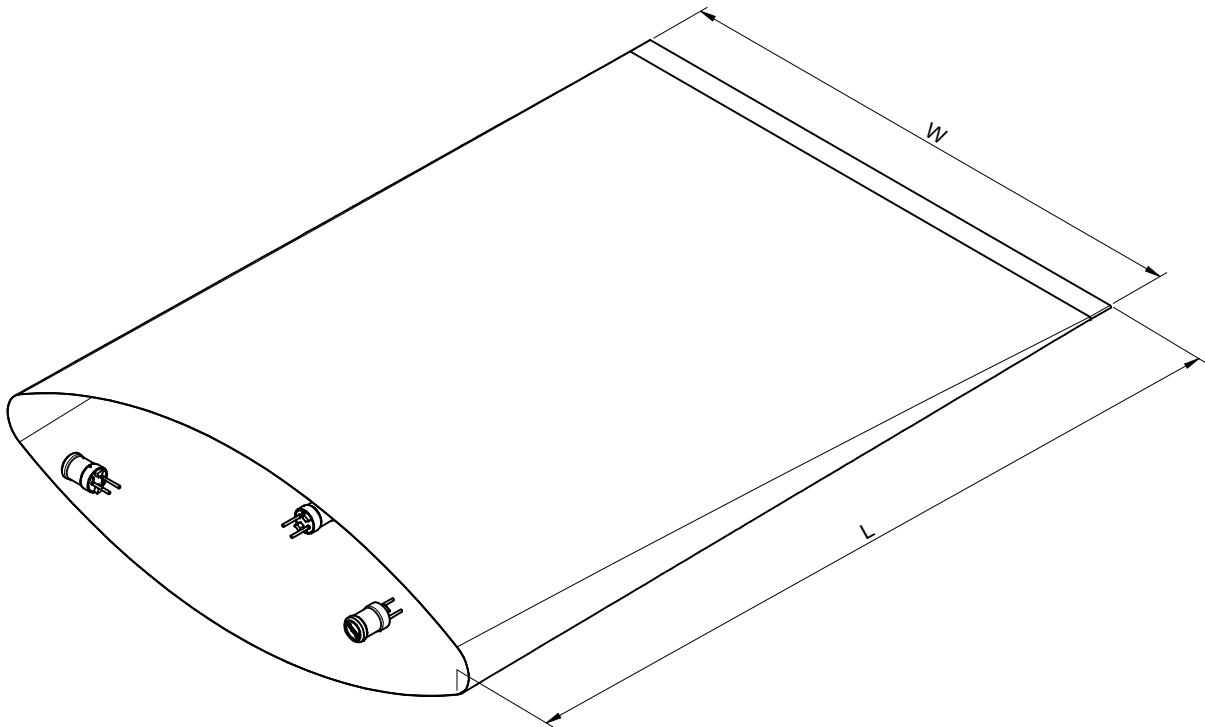

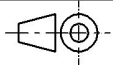

Soldering:

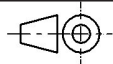
Packaging:

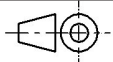
