


Figure 1. Forward Current vs. Forward Voltage




Figure 2. Forward Current vs. Forward Voltage

V_F - Forward Voltage (V)




Figure 3. Reverse Current vs. Junction Temperature




Figure 4. Diode Capacitance vs. Reverse Voltage





Figure 5. Typ. Non Repetitive Forward Surge Current vs. Pulse width
