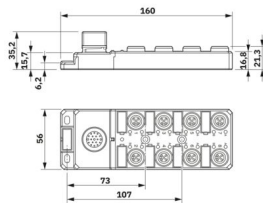

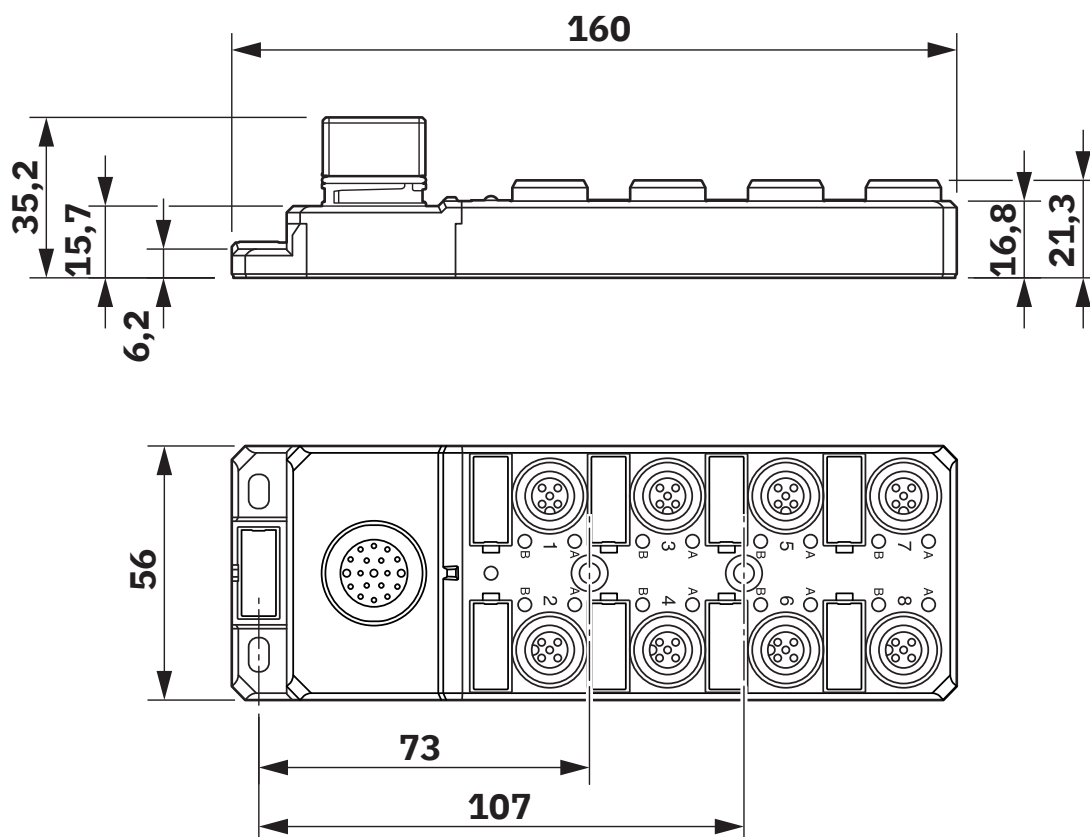

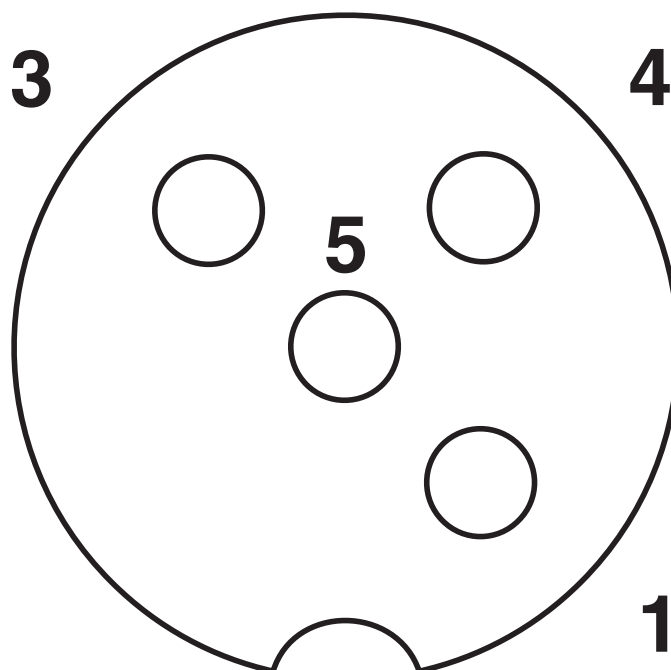

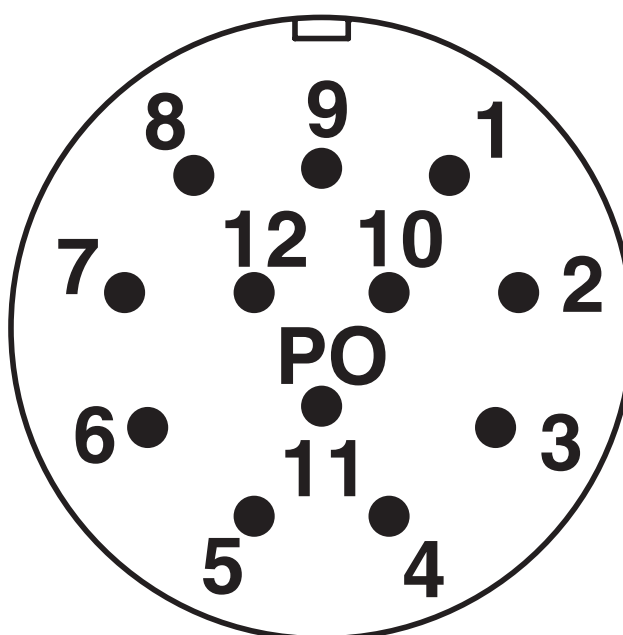

Schematic diagram



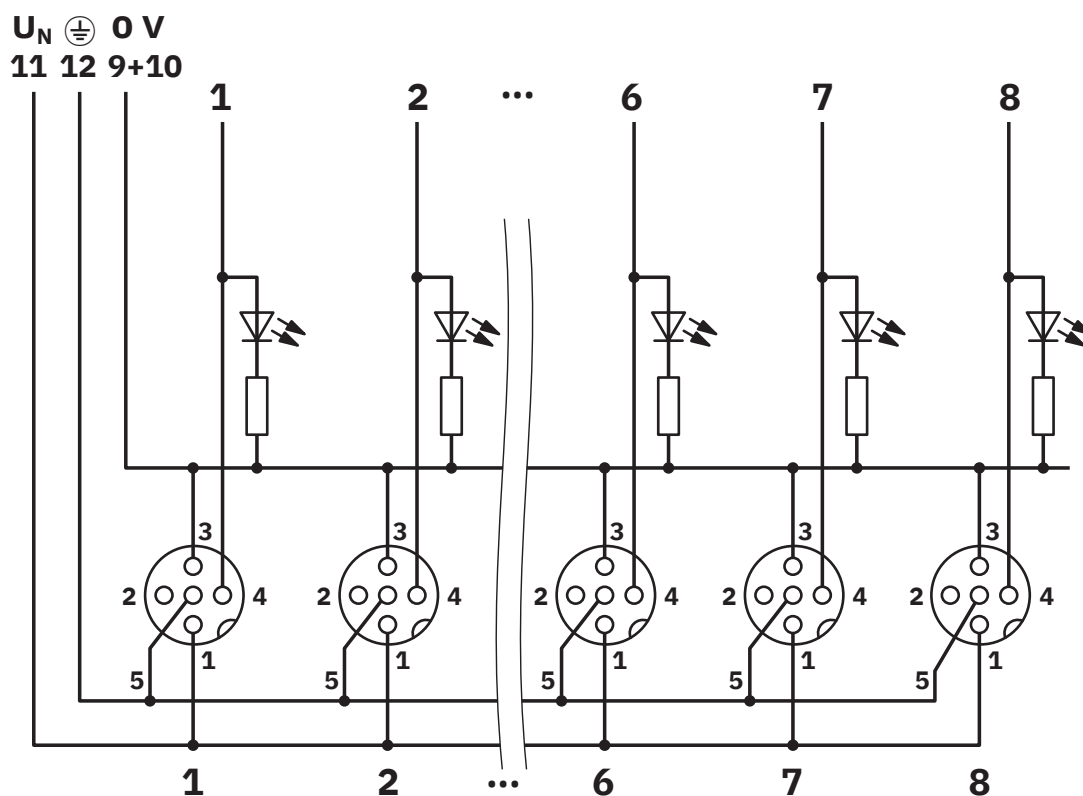
M23 plug connection pin, 12-pos.
